Ariab is located in Sudan's read sea hills. The company runs more than a dozen open pit gold mines located at lat. 18 15, 19 20 and long 36 30 34 30. The company was established on Dec 1990 as a partnership between the French government and the Sudan government. Ariab has been producing gold since 1992, and to date has produced more than 88 tons of pure gold. Most of the ore mined to date comes from high grade oxidized ore.

Ariab owns an area of about 45000 KM2. Since 2007, AMC started to drill for the deeper copper deposits (VMS) volcanogenic massive supplied, which has proven to be very rich in copper, gold silver and zinc. As of 2015 the French government has totally withdrawn from the partnership.

Most recently, Ariab had carried out a detailed study in three very promising mines, Hassai south, Hadal awatib, and Hadayamet pits.

Ariab has played a big role the development of rural areas, by establishing a new village (Bir Ajam village). Infrastructure building in Bir Ajam includes a hospital, a school, fresh water, and health care. Ariab also provides the locals in surrounding areas with water and health care. ariabmining.net


